SUPPLEMENTARY REGULATIONS

- The Humber Register, on behalf of the Inter-Register Club will organise a Scatter Rally taking place in North Shropshire on Saturday 27th August 2022, starting and finishing at the Punchbowl Inn, West Felton, SY11 4EH.
 Map Reference: OS126: 347 256
- 2. Held under the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA) and these Supplementary Regulations.and any instructions that the organising Club may issue for the event. The event will run under a MotorSport Uk Rallying Navigational Scatter Permit.

Permit Number 127219

3. The event is open to pre-1963 cars entered by fully elected members of clubs comprising the Inter Register Club as listed below. The event is also open to current members of the VSCC in their VSCC eligible cars.

All competitors (driver and passengers 18yrs old and over) must hold a MotorsportUK RS Clubmans Licence which is free and can be applied for on-line at https://rsclubman.motorsportuk.org/.

Proof of membership of an Inter-Register member club or invited club may be inspected at Documentation.

- 4. The event is a round of the 2022 Inter-Register Championship.
- 5. The programme of the event will be:
 - Scrutineeering and Signing on from 10.15 am. at the Punchbowl Inn, where refreshments will be available from 10.00. Any car not signed on by 11.00 may be penalised or refused a start.
 - Route cards will be issued from 11.00 am. Cars will leave in their own time.
 - Late lunch will be available at around 15.30 back at the finish see Paragraph 18, below.
- 6. Competitors will cover around 65-70 miles depending on their chosen route. The OS Landranger map required for the event is OS126 (Edition March 2019 used by your organiser). Apart from a Romer, ruler, pencils and eraser no instruments are required. Navigation will be by various common methods and should be readily achievable and unambiguous. Novice and beginner navigators (see Para. 9 below) will be provided with additional assistance if required.
- 7. All entrants' cars must be road legal, i.e. 'taxed' for the road, and, all drivers must hold a current Driving Licence for the car entered. Drivers should ensure that their vehicle insurance will cover use on this event as technically it is classified as a Rally Event by Motorsport UK. Insurance companies generally accept use on this type of event with normal car insurance because it is with no element of timing or speed on the public highway and drivers must comply with Road Traffic Acts at all times.
- 8. The event will consist of two classes: Experts and Novices. A novice crew is one where no member has won a 1st, 2nd or 3rd class award, or has been placed 1st, 2nd or 3rd, in any VSCC or IRC navigational event in the previous three years. (If anyone wishes to 'tour' and not compete, please bring the map and it will be marked for you on the day.) Absolute beginners (ie first event) will be welcome to extra assistance. A team comprises the three highest placed cars of a single marque.
- 9. The Entry List opens on the publication of these Regulations and Closes on Saturday 20th August 2022. Entries *may* be accepted on the day (cash payment only), subject to notifying the event secretary on or before Saturday 20th August.

10. Entry Fees will be £20.00 per vehicle, to include bacon roll and tea or coffee before the event.

All entries must be made on the official entry form accompanied by the appropriate fee. Cheques should be made payable to "Nigel Coulter" (no post-dated cheques, please) and sent to the Secretary of the Meeting:

A full refund will be given if entries are withdrawn and notification is given in writing or e-mail by the closing date. Cancellation after the closing date may incur loss of entry fee.

- 11. The maximum entry for this meeting, including reserves, is 30. The minimum is 8. Should this latter number not be reached the organisers reserve the right to cancel the event. Entries will be accepted in order of receipt; however should the event be oversubscribed, priority will be given to Inter-Register Championship contenders.
- 12. Final Instructions will be e-mailed to competitors on 21 August 2022 and will include procedures for the start venue, a list of entrants and competitor numbers. Competitors will receive e-mailed declaration forms which will include a self scrutineering statement, covid 19 health statement, and names and addresses of all passengers to be carried in the vehicle. These documents must be signed and e-mailed back to the event secretary before 12.00 noon on Wednesday 24 August 2022, including any details or alterations from those submitted on the Entry Form.

 As there will be no detail scrutineering, every driver must sign the organisers' document confirming that his vehicle is in good working order and safe to use on the public highway. The event Scrutineer has authority to decline a start if he deems the condition of any competing vehicle to be unsatisfactory the Scrutineer's decision is final and not subject to protest.
- 13. The officials will be: Clerk of the Course: Nigel Coulter Scrutineer: Jim Wood
- 14. Any ties will be resolved in order of the number of adult crew, horsepower (RAC Rating) of the engine then the age of the car concerned.
- 15. Marking: There will be 21 locations to plot, and on visiting them a question must be answered, on the Score Card provided, as proof of visit. The locations will vary in score, ranging from 3 points to 15 points depending on the difficulty of plotting and /or getting there and/or funding the answer once there. You should aim to visit a MAXIMUM of 14 locations. If more than 14 answers are submitted only the 14 LOWEST scores will be counted. There will be a target finish time and penalty points will be awarded at the rate of one point per minute late after this time. Maximum lateness is 30 minutes. Arrival after this limit might result in disqualification.
- 16. Any Protests must be lodged in accordance with the MSA Regulations Section C5
- 17. Awards: There will be:
 - Prizes for 1st, 2nd, and 3rd places in each class (subject to minimum of 10 in class); and a team prize. Special awards may be made at the discretion of the organisers.
 - The Trowbridge Bowl for the first overall, and the Trowbridge Novice Award for the best Novice.
 - Inter Register points will be awarded for individual places overall, and for team places, where a team comprises up to the highest scoring three cars of an Inter-Register Club.
- 18. As part of the entry fee, tea or coffee and bacon rolls will be available prior to the start at the Punchbowl Inn. High tea will then be available at the finish comprising cottage pie and peas at a cost of £8.00 per head. Please advise on the Entry Form if you have any specific dietary requirements.
- 19. Petrol is available at the MileEnd services on the A5 about 3 miles NW of the start at OS126: 309 285, or at Nescliffe Services on the A5 about 4.5 miles SSE of the start. Please ensure you have an adequate fuel supply before signing on.
- 20. If anyone requires accommodation locally, there are B&Bs in the area and Oswestry has hotels including a Travelodge and Premier Inn (www.oswestry-welshborders.org.uk is a good place to start.). Please contact Nigel Coulter (details in Paragraph 10, above) if help is required with this.
