Event Regulation

- The meeting is open to cars belonging to members of the MG Car Club of Italy and to members of foreign MG Car Clubs.
- Vehicle allocation will be, 20 prewar and T series, 20 MG A, 20 MG B, 5 MG F e TF, 5 RV8, 4 Midget, 4 MG C, 2 YA-YB. The organizing committee reserves the right to any exception to this.
- **The registration period closes on June 30th 2021.**
- Registrations will only be accepted following the completion of the registration form for this meeting. If the registrant does not receive any negative answer within two working days after submitting the registration form the registrant may consider the registration to be accepted.
- After the tacit acceptance of the registration the participant must pay within the next **ten** working days either a deposit of € 1.000 (one thousand Euros) or the full amount.
- In the case of payment of a deposit, the remaining amount must be paid latest by the 30th June 2021.
- The first 50 crews who sign up will be entitled to a sea view room.
- The first 80 crews who will register will be admitted.
- If the number of registered exceeds the 80 expected, a waiting list will be created.



PENALTIES AND CANCELLATIONS POLICY:

- 10% of the participation fee up to July 28th;
30% of the participation fee from 29h to August 12th;
75% of the participation fee from August 13th to August 27th;
90% of the participation fee from 28th August to 3rd August;
100% of the participation fee from 2nd September to the day of departure;
